

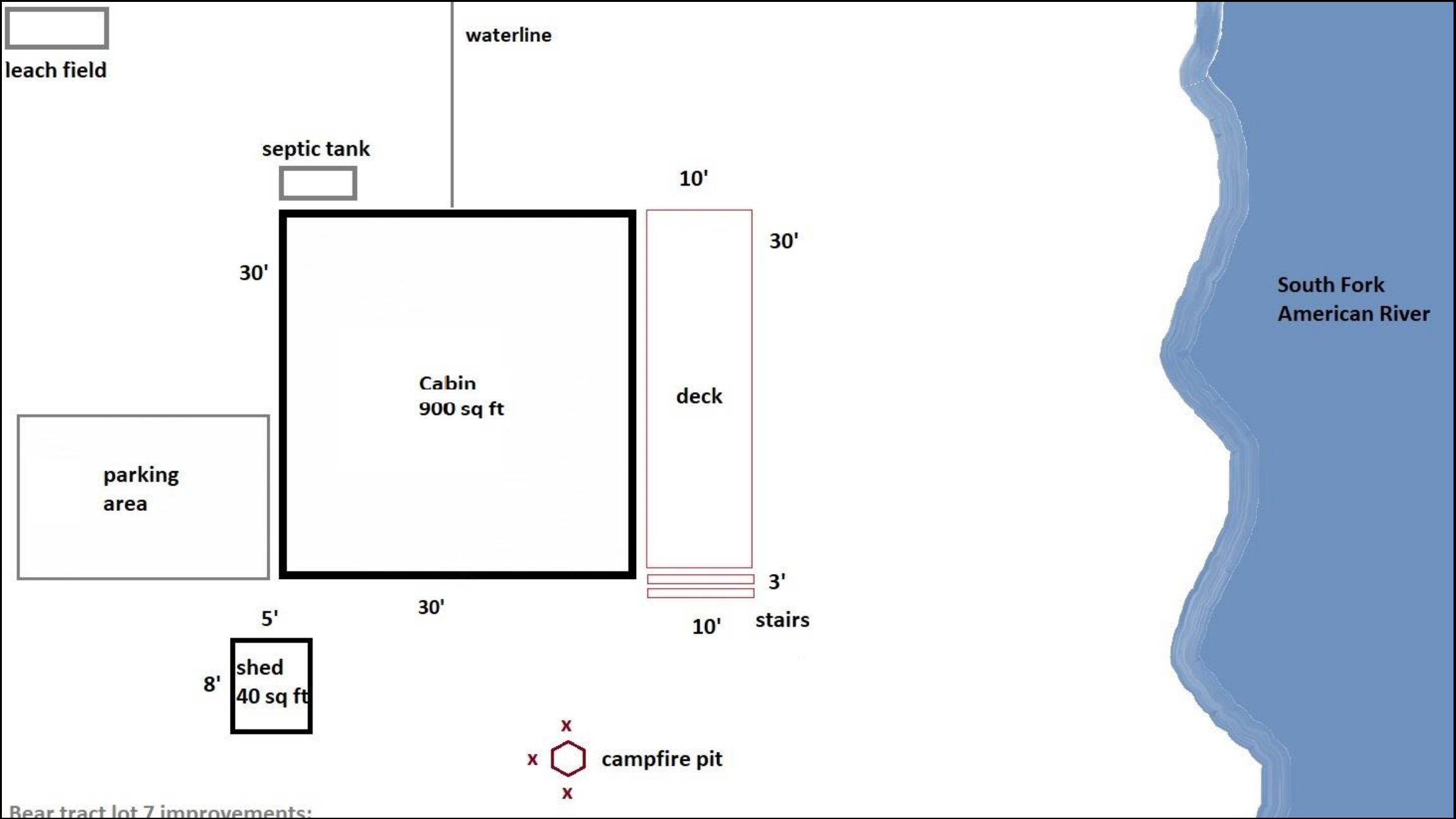
Eldorado National Forest Recreation Residences

Permit Reissuance Process

- Certified Letters were delivered to all ENF cabin owners identifying their compliance status and next steps to receive a new 20-year term permit.
- Special Use Permit Administrators will begin lot inspections on all cabins beginning in mid- September to verify compliance.
- Compliant cabins that have submitted their O&M plans will receive a new 20- year term permit for signature in the months preceding their current permits expiration.

Operation and Maintenance Plans

- Completed O&M Plans must be submitted before the new term permits can be issued.
- Please fill out every prompt on the forms, even if you don't have any projects planned or issues to address.
 - In this case just write "N/A" or "None"
- Lot diagrams need to be included with the O&M Plan. Please include the square footage of your improvements either in the table on page 2 of the plan or on the diagram.

Burn Permits

- CalFire is no longer administering residential burn permits for residences that have an address outside of their "state responsibility area" i.e. any address within the National Forest.
- The ENF is currently working on a method to safely allow permit residential burning within tracts and permitted areas.
- For now, please obtain an interagency Campfire Permit, available online on CalFire's website or in one of our local FS offices.
- Campfire permits allow for "campfires" or "warming fires" up to 2'X2'.

Roadside Hazard Tree Project

Hazard trees within 200 feet of the road will be cut and the material will be removed.

Noise, Traffic, and Dust

The contractor needs to know where your septic tank, water lines, propane lines, etc. are.

Hazard Trees

- It is the permit holder's responsibility to identify and mitigate hazards to your cabin
- Hazard Tree Authorizations
 - Placerville
 - Email sm.fs.pvl-rec-res@usda.gov
 - Approximate height and diameter at shoulder height
 - Species (if known)
 - Photos
 - Amador and Pacific
 - Call or email the rec res office
 - They will go and paint the tree
